Appendix 3 Awards

1. POLICY STATEMENT

Target Rifle Victoria Inc. conducts a number of competitions. These competitions are conducted under their own unique rules and regulations but all fall under the general auspice of the ISSF rules and regulations, WRABF rules and regulations and TRA Australian rifle rules in the conduct of our sport.

This policy aims to set a standard for the conduct of those competitions conducted by Target Rifle Victoria Inc. (TRV) to ensure fair and equitable competition for all.

2. OUTCOME

All persons who are associated with Target Rifle Victoria Inc. will be aware of their rights and responsibilities in relation to the conduct of and their participation in TRV competitions.

3. APPLICABLE TO:

Target Rifle Victoria Inc. Council, Administration and TRV member clubs which includes members of those member clubs and all entrants in TRV competitions.

4. PROCESS:

4.1 ENTRY INTO COMPETITIONS

Eligibility criteria will be found in the rules for the relevant match. For TRV competitions all entrants, with the exception of suitably authorised international visitors, are required to be a current financial member of TRV/TRA and hold a current firearms licence or Junior permit unless otherwise stated in the rules for the individual competition. Entry to a TRV competition implies acceptance of the rules of that competition, including eligibility rules and any contravention of those rules will result in disqualification or the application of such other sanctions as are available within the rules of the individual competitions. Prohibited persons are not permitted to enter into any TRV Competitions.

4.2 HIERARCHY OF RULES FOR TRV COMPETITION.

3. This Competition Policy
4. TRA Australian Rifle Rules
5. ISSF Rules and Regulations / WRABF Rules & Regulations This hierarchy shall apply to all of the competitions listed.

4.3 COMPETITION AGE CATEGORIES

- i. Sub-Junior - Sub-Juniors are shooters who will be under the age of 16 on first day of the competition. (Sub Juniors are eligible to win Sub Junior, Junior and Open categories)
- ii. Junior - Juniors are shooters who will be under the age of 21 on first day of the competition. (Juniors are eligible to win both Junior and Open categories)
- iii. Veteran - Veterans, for TRV competition are shooters who have reached the age of 65 on the first day of the competition and for TRA competitions shooters who have reached the age of 60 years on December 31st in the year of the competition.
- iv. Senior - All other competitors other than IPC competitors are Senior competitors and compete in the open category.

4.4 COMPETITION YEAR

The TRV competition year begins on January 1 and finishes on December 31. All annual TRV events are to be completed within a shooting year.

4.5 COMPETITION RULES

Competition events and rules are listed in Appendix 1

4.6 RECORDS

TRV Records may be set at National Championships shot in Victoria, TRA sanctioned events shot in Victoria, Victorian State Championships, Grahame Lawler Matches and Warren Potent Matches shot at the nominated range, Master Marksman and Benchmaster matches with a TRV Technical Delegate in attendance. Where 20m and 90m disciplines are run in conjunction with a clubs Master Marksman/Bench Master event they will also be eligible for State Records.

Sub-Junior competitors are eligible for records in Sub-Junior, Junior and Open categories.

Junior competitors are eligible for records in Junior and Open Categories.

Veteran competitors are eligible for records in Open and Veteran Categories.

4.8 MODIFIED PRONE POSITION IN TRV COMPETITION

- i Shooters seventy years or older and those with a medical condition curtailing their ability to get into the prone position for shooting may elect to shoot from a shooting table in accordance with the IPC rules for prone.
 - The athlete's chest and/or abdomen may rest on the board or table provided that the athlete is not also in supporting contact with a backrest.
 - Both elbows must rest on the table or board and a sling used
 - The upper arms must not touch the table or board
 - The forearm must not form an angle of less than 30 degrees from the horizontal, measured from the axis of the forearm.

This modification to the policy to apply to all TRV prone competitions.

5 RISK MANAGEMENT

This Competition Policy forms a part of the Risk Management system of Target Rifle Victoria Inc. By observing this policy, it is expected that risk in relation to this policy can be monitored both by member clubs and Target Rifle Victoria Inc.

APPENDIX 1

COMPETITIONS AND RULES

Competitions conducted by TRV are (with current rules for conduct of competition as listed):

1. SPECIAL RULE – RESTRICTED MOVEMENT

The following rules apply when government regulations do not permit free movement of people between Australian States and Territories or Regions within Victoria.

- i. Satellite centres may be setup so competitors can participate in the competition.
- ii. Where the restrictions affect interstate travel there will be one satellite centre in each Australian State or Territory. Where the restrictions affect travel within Victoria there will be one satellite centre in each of the impacted regions.
- iii. Each satellite centre will have to have appropriate officials as determined by the organising committee and satellite centres range requirements to run the event.
- iv. Only competitors shooting in Victoria or competitors shooting at satellites that are affiliated with TRV will be eligible for 'State Champion' Title and for awards in the Graded, Junior, Sub Junior and Veteran categories of the TRV state championships. However, all competitors will be eligible for 'Open' awards.
- v. When this event is being run in conjunction with a Shooting Australia endorsed Performance Series event all competitors in the 'Open' category must comply with ISSF rules. (ie. TRA Supplementary Rules and Regulations do not apply to these athletes)

2 STATE CHAMPIONSHIPS

A standing committee consisting of the Judging, Outdoor and Indoor Convenors and if required a representative of the host club shall organise and run the State Championships. The committee will recommend to Council the venues for the following year's events by September for inclusion in the competition calendar.

3. MASTER MARKSMAN 50M PRONE SERIES AND BENCHMASTER 50M BENCHREST SERIES

Applications by a club, one per club per year, for inclusion in the master marksman and benchmaster series must be completed on the approved form and in the hands of the secretary by the date set.

Two day competitions shall attract points on both days.

Subject to a report from the appointed technical delegate and the results being forwarded to the grader in the approved format within 14 days of the completion of the match competition points will be accumulated from the placings at participating club prize shoots. Eleven (11) points for first place through Two (2) point for tenth place for scratch. All remaining competitors shall be awarded One (1) point.

The eight best results in these matches shall be totalled for each competitor to decide to series winner in both Open and Junior competition.

Tied scores will be resolved in favour of the competitor with the highest number of higher placings. If a tie persists the higher placing will go to the competitor with the highest aggregate score over the (up to) eight competition matches.

4. PENNANT COMPETITION

Pennant competitions shall be held each year.

All shooters nominated to a team must have a TRV grade or provide three (3) recent scores. Only shooters named on the entry form are eligible for individual awards. A shooter may only compete in one team in any one pennant competition.

Any shot holes outside of the sighting target area will be counted as a competition shot unless proof in the form of a crossfire detection card is produced.

Shooting may commence on receipt of the competition stickers.

Stickers, where mandated, shall be placed behind the centre of a competition target prior to shooting. All competition targets must have the following written on them:

1. Shooters Name and Signature
2. Shooters TRV Membership Number
3. Date Shot
4. Witness Name and Signature

Targets shall be scored by the club official nominated on the Pennant Entry Form. Scores must be delivered to the competition officer by 8pm on the Monday following the shooting week for that round.

Targets must be retained until the competition is declared and results become final.

If requested, a club must send the targets for selected round/rounds to the competition convenor for verification. Any targets not sent when requested will be disqualified.

Points will be awarded for each round, four for a win, two for a tie and zero for a loss. Byses must be competed for points to be awarded.

If two or more teams in a section are tied on points after the last round of competition the result shall be determined by shoot-off. If there is still a tie after the shoot-off each team remaining in the tie will be declared joint winners.

Any shoot-off shall be conducted under the direction of the competition convenor.

Clubs may enter either or both 20m prone and bench rest paper and electronic pennants.

IPC pennants will be held in each discipline if at least three teams are entered.

APPENDIX 2 - TRV GRADES

A TRV Average and Grade will be calculated for each discipline. Note: scores shot as part of Pennant competitions will be treated as separate disciplines as they are not full matches. Pennant grades will be based on the number shots in each round of the Pennant. (ie. 20m Prone 10 Shots, 10m Air Rifle 30 Shots) The average for a discipline is calculated as follows:

If a member has < 7 scores for a discipline, the average is the average of the available scores.

If a member has 7 scores for a discipline, the average is the sum of the scores excluding the highest one divided by 6.

If a member has 8 or more scores for a discipline, the average is the sum of the most recent 8 scores less the highest and lowest score divided by 6.
